Erika Karp is a finance and capital markets leader with 25+ years of experience in investment advising, wealth management, banking, and sustainable investing. As the founder of Cornerstone Capital Group, a \$1.3B ESG-focused advisory firm later acquired by Pathstone, she has been a pioneer in integrating environmental, social, and governance (ESG) factors into investment decision-making. Previously, she was Managing Director and Head of Global Sector Research at UBS.

A founding board member of SASB and a former member of the World Economic Forum's Global Agenda Council, Erika has advised institutions and private clients on long-term, sustainability-driven investments. She is a sought-after speaker, having addressed the UN General Assembly, NYSE, OECD, and the Vatican on sustainable finance.

Recognized among Real Leaders' "100 Women in Impact" (2021) and Worth Magazine's "Groundbreakers 2020," Erika holds an MBA from Columbia University and a BS in Economics from the Wharton School.

Kanwalroop Kathy Dhanda, PhD

Kanwalroop Kathy Dhanda is a Professor of Management and Associate Dean of Faculty Affairs at the Welch College of Business, Sacred Heart University. A former Fulbright Scholar of Arctic Studies, she previously taught at DePaul University in Chicago. She has also been a Visiting Professor at the University of Iceland and Fairfield University, as well as an Invited Professor at AUT University in New Zealand and the American University in Paris.

Her academic scholarship focuses on sustainability issues with a primary emphasis in the areas of environmental modelling, carbon markets, emissions trading, and sustainable supply chains. She has published about 40 papers in Operations Research, Journal of Business Ethics, Academy of Management Perspectives, Energy Economics, Journal of Public Policy and Marketing Policy Watch, Organization & Environment, Journal of Environmental Economics and Management, as well as other journals. She is also the co-author of three books: Environmental Networks: A Framework for Economic Decision-Making and Policy Analysis (Edward Elgar); Sustainability: Essentials for Business (Sage); and Business & Sustainability (Waveland Press).

Mahfuja Malik, PhD

An Associate Professor of Accounting and Information Systems in the Jack Welch College of Business at Sacred Heart University. Dr. Malik's research interests lie in the realm of financial accounting. In particular, she is interested in corporate governance, corporate social responsibility, and financial and non-financial disclosures related research. Her research has been published in the Journal of Business Ethics, Journal of Corporate Finance, Accounting Horizons, Journal of Management Control, and International Review of Business Research Papers. She has presented her papers at numerous conferences including American Accounting Association (AAA) Annual Meeting, AAA Ohio Region Meeting, AAA Public Interest Section Midyear Meeting, AAA Mid-Atlantic Region Meeting, AAA Annual Meeting, AAA Northeast Region Meeting, and International Business Research Conference. Weijia Peng, PhD

Weijia Peng, Ph.D. is an Assistant Professor of Business Analytics at Sacred Heart University, specializing in financial econometrics, forecasting, machine learning, big data analytics, and fintech applications. She earned her Ph.D. in Economics from Rutgers University, and her research has been published in top academic journals such as Finance Research Letters and Journal of the Royal Statistical Society, Series C. She has received several awards, including the Jack Welch College of Business & Technology Research Grant, the Best Doctoral Student Paper in Financial Markets Award, and the Monroe Berkowitz Memorial Award in recognition of outstanding dissertation work. She has served as a guest editor for the Journal of Risk and Financial Management and as a referee for top-tier journals. She is also providing consulting services in data science, focusing on AI-driven trading strategies and healthcare data analytics. She is actively engaged in interdisciplinary research and has collaborated with leading scholars and industry professionals on projects involving financial market volatility, macroeconomic uncertainty, and applied machine learning.

Michael Herley, DBA

Herley was named an Assistant Professor of the Practice in Business Analytics and Information Systems (tenure track) at St. John's University, effective August 2023. He was previously a Visiting Assistant Professor. He earned his D.B.A. in finance from Sacred Heart University's Jack Welch College of Business and Technology, his M.B.A. in corporate finance from St. John's University, and his M.S. in mathematics from Fairfield University. Prof. Herley prides himself on being an excellent instructor who emphasizes practical applications and meaningful results in the classroom. With over 27 years of industry experience, Dr. Herley was previously a Partner at Kekst CNC on Madison Avenue until June 2019, when he left to launch his entrepreneurial venture, Southport Strategies LLC, and focus on his executive doctoral degree and research. In March 2023, he was profiled in <u>The CEO Magazine</u>. Dr. Herley's research leverages regime-switching models and machine-learning techniques to improve time-series econometric forecasts. His ongoing research projects focus on examining the relationship between financial and economic variables at different levels of market risk using self-exciting threshold autoregressive and Markov-switching models.
